







Please find attached the seed treatment plot data from 2022 from the Research and Technology Plots at Bath for Agtegra Cooperative. Our additive- Righstart White Mold SDS (RS WM SDS) looked excellent again in the plots. This plot was EXTREMELY wet at planting time, and you can see the stand counts really suffered as a result (see the last page for stand counts). However, the extra additives paid good dividends, with a gain of 0.87 to 0.94 bu/acre. This plot was planted with NK14-C7XF soybeans. Which is one of the top yielding varieties in the region

Neither white mold nor SDS occurred at detectable levels at any of the locations. Despite this, the Heads Up seed treatment increased soybean yields by 2 bushels per acre at two locations (Branch 2 and Allegan). Yield was not affected at the other two locations. When all four locations were combined and analyzed, the Heads Up seed treatment increased yield by an average of 1.2 bushels per acre and increased income by \$12.00 per acre.
